## NOTICE TO MARINERS

### NO 7 OF 2015

#### FISHERIES SURVEYS – SWANSEA BAY

Turnpenny Horsfield Associates are planning to carry out multiple fisheries surveys in February and March 2015. Provisional dates, which barring any logistical problem should not change, are as follows:

- Friday 13<sup>th</sup> February
- Thursday 19<sup>th</sup> February
- Friday 27<sup>th</sup> February
- Thursday 5<sup>th</sup> March
- Monday 16<sup>th</sup> March

It is planned to carry out plankton surveys of multiple transects in three main areas: off Port Talbot, off Swansea Marina and off the Mumbles. A bongo net (dual plankton nets) will be fished for <2min trawls from the vessel *Heather D.* trawling at one to two knots. The sampling gear is fished to cover the full depth of the water column but there is no contact with the seabed.
